**OSVS is located at 1480 South County Trail (Route 2) in East Greenwich, RI, 0.5 miles south of Warwick Showcase Cinemas.**

**From Points South and West:**  
Take Route 95 North to Exit 8A (Route 2 South). Go straight through the Division Street (Route 401) intersection. OSVS is located 0.5 miles south of the intersection on the left.

**From Points South and East:**  
Take Route 4 North to Exit 8B (Division St.). Pass the Cinema on the right and at the light take a left onto South County Trail (Route 2). OSVS is located 0.5 miles south of the intersection on the left.

**From Points North and West:**  
Take Route 295 South to 95 South. Take Exit 8 (Route 2 South). Take a right off the exit. Go straight through the Division Street intersection (pass the Cinema). OSVS is located 0.5 miles south of the intersection on the left.

**From Points North and East:**  
Take Route 95 South to Exit 8 (Route 2 South). Take a right off the exit. Go straight through the Division Street intersection (pass the Cinema). OSVS is located 0.5 miles south of the intersection on the left.
